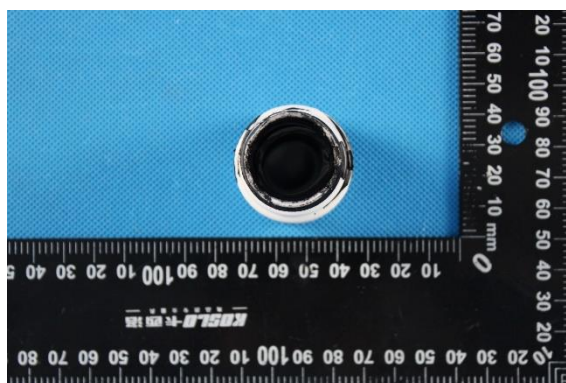
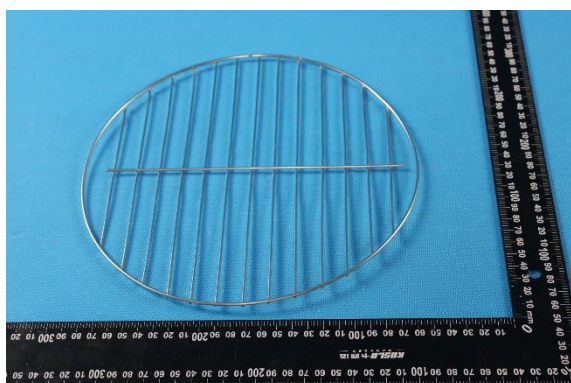

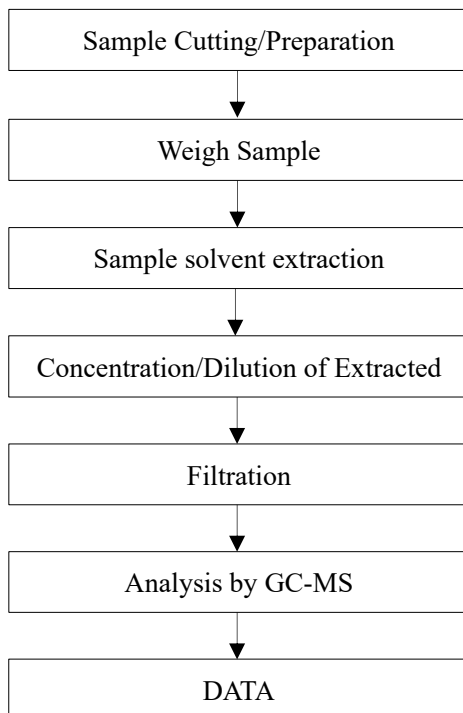

Test Flow Chart of AZO



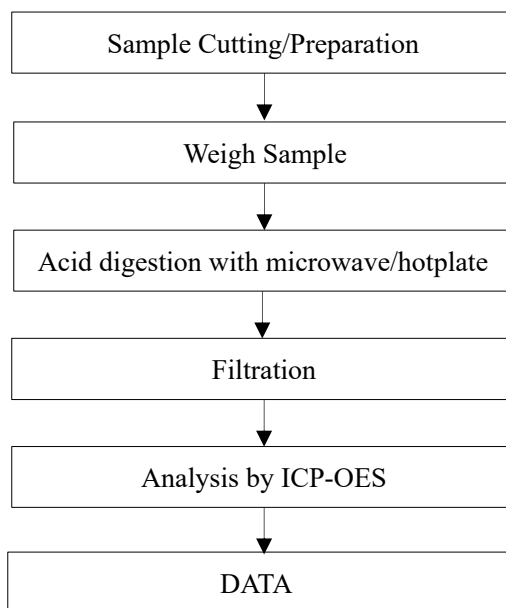

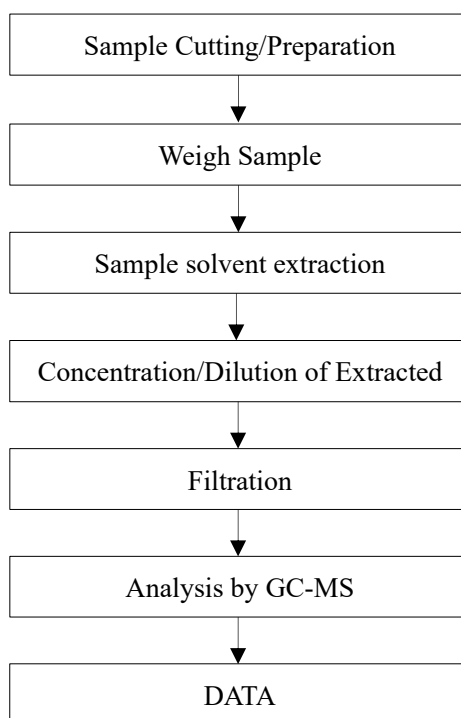

Test Flow Chart of Phthalates



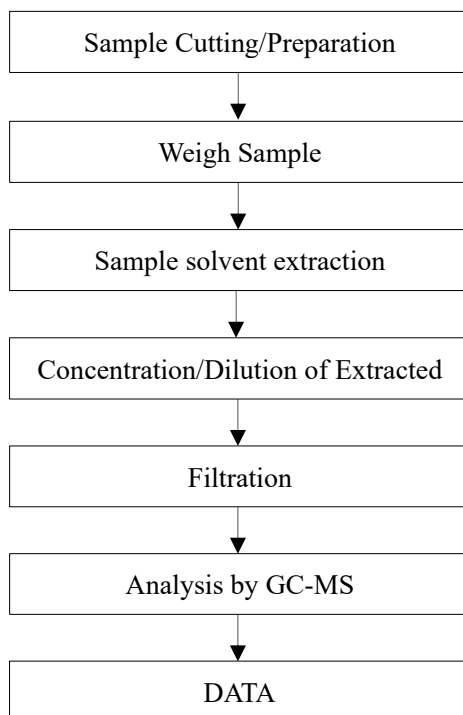
