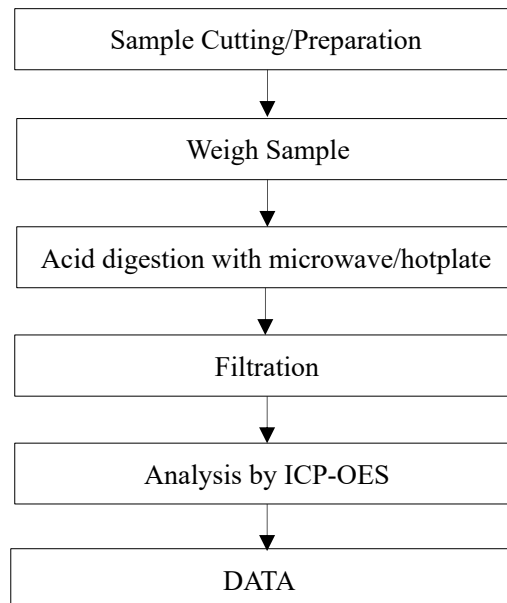

**Test Flow Chart of Heavy Metal Content**

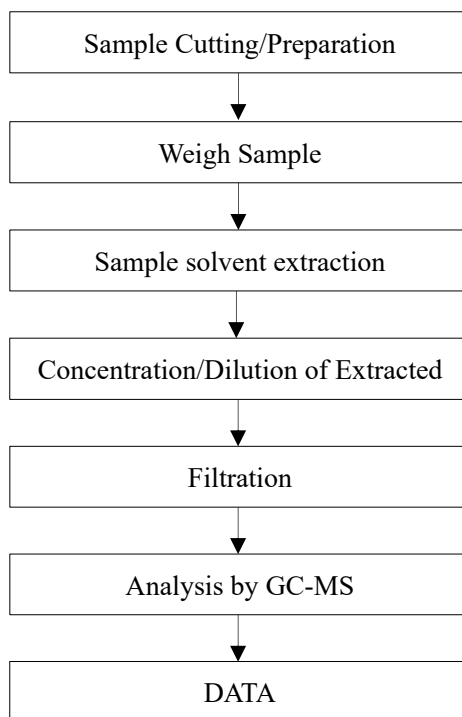

### Test Flow Chart of Phthalates



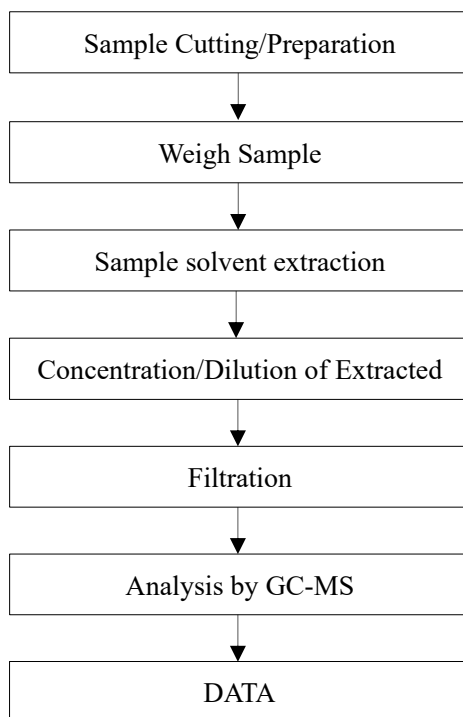

### Test Flow Chart of Polycyclic-aromatic Hydrocarbons (PAHs)



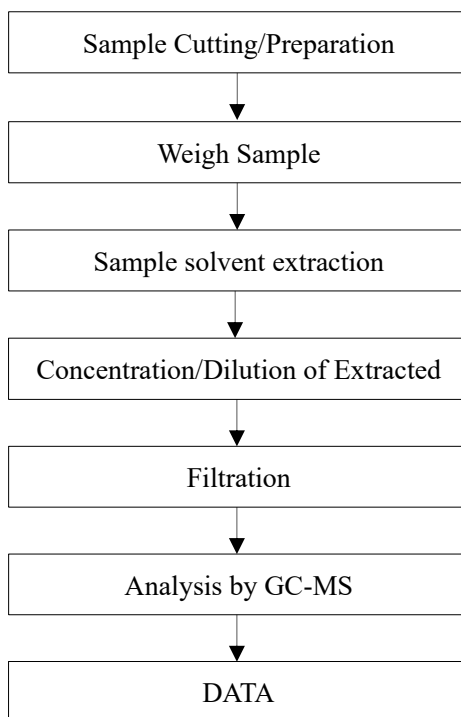

### Test Flow Chart of Pentachlorophenol (PCP)



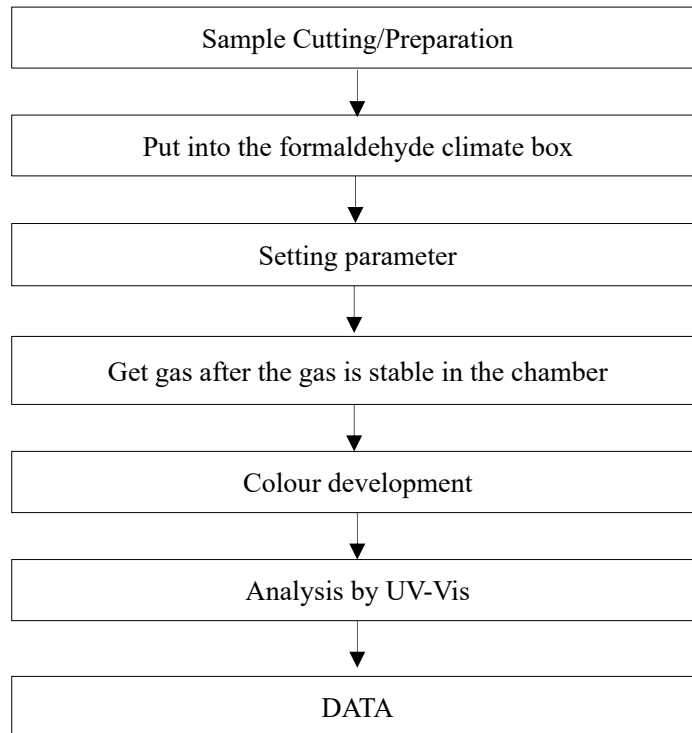
