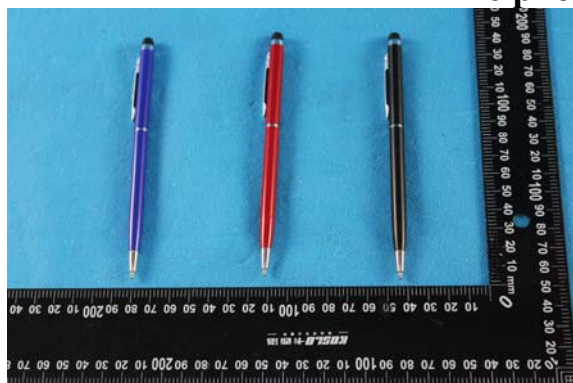

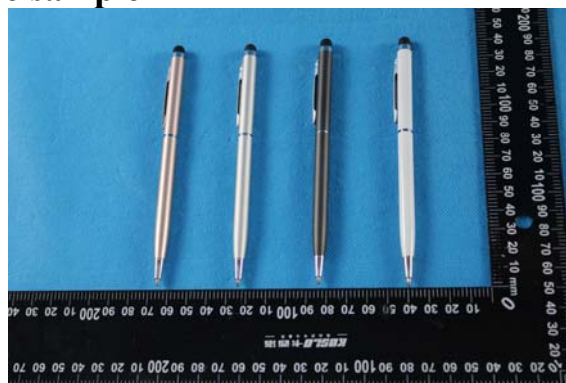

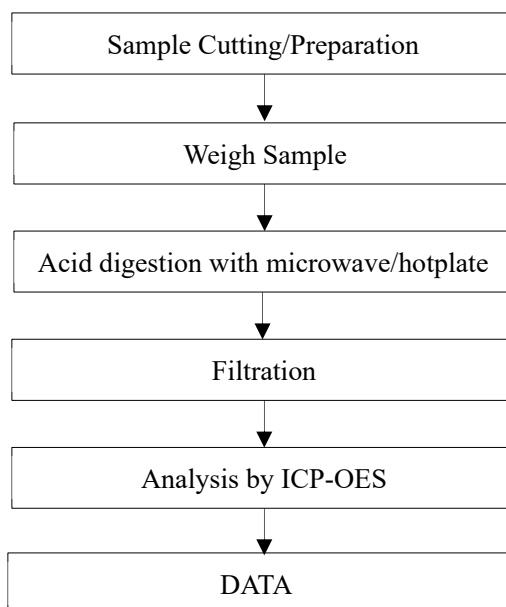

## Test Flow Chart of Heavy Metal Content



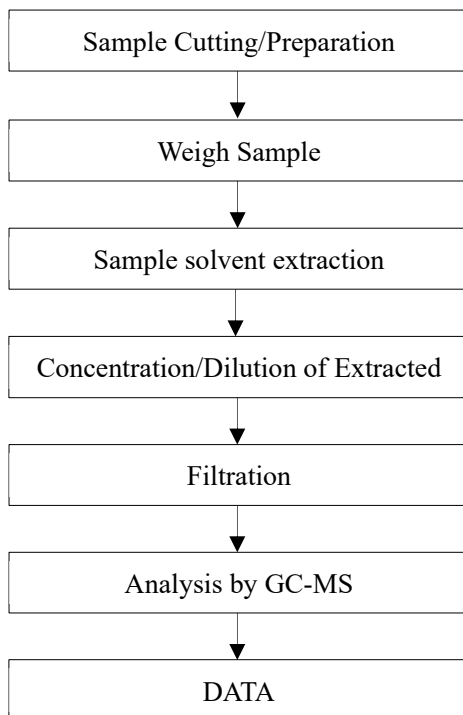

**Test Flow Chart of Phthalates**

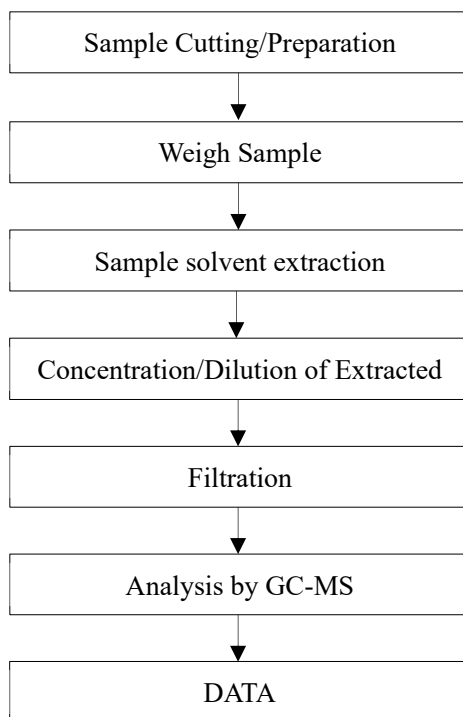
