MO7380	<ol style="list-style-type: none">1. Flex the inside metal-chip a few times until the pack starts to crystalize and heat up and harden.2. Gently knead the hardening liquid.3. Fully immerse the Warmer into a pot of boiling water for approximately 10 to 20 minutes until all crystals in the pack have disappeared.4. The sample shall perform its intended use after 50 cycles test according to instruction sheet provided.	The sample met the requirement.

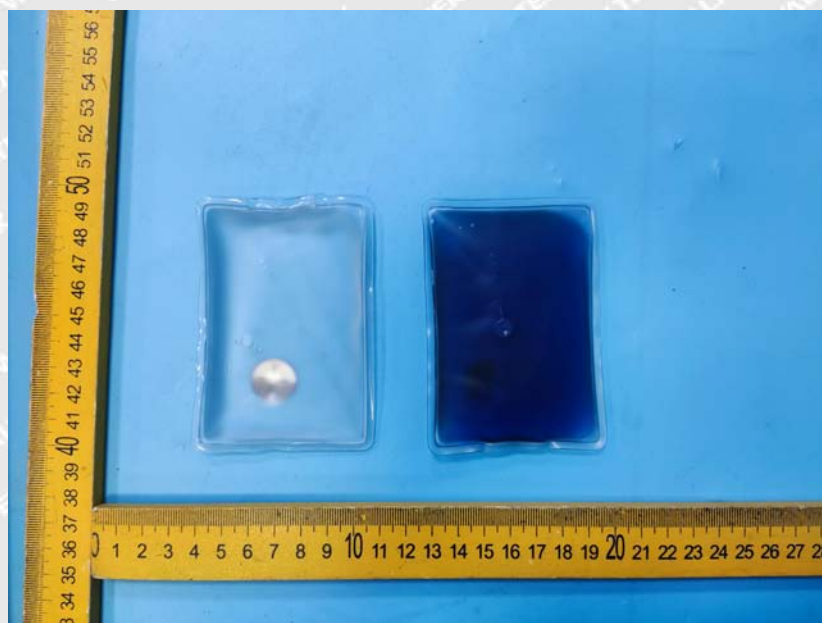


Photo 1 -- Model IT2660

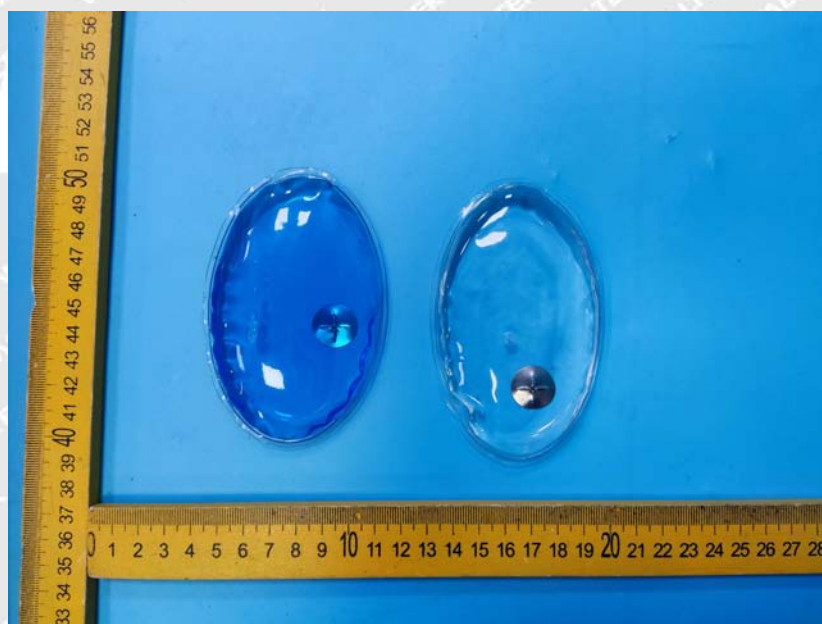


Photo 2 -- Model MO8496
